Population	Nigeria is the largest African country, composed of > 250 ethnic groups. Hausa 30%,

Geography	Western Africa, bordering the Gulf of Guinea, between Benin and Cameroon. ³
Languages	English (official), Hausa, Yoruba, Igbo (Ibo), Fulani, > 500 indigenous languages.4

Education and literacy	62 % is literate, females much lower than males (52.7% resp. 71.3% est. 2021).6 Gross
	primary school enrolment rate is 86% in 2018 (64% reaches last grade of primary).
	Primary education is free and compulsory, but 10.5 million of children aged 5-14
	years are not in school. Only 61% regularly attend primary school. In the north, this is
	53%, for girls 47.7%, meaning that > half of the girls are not in school.8
	School facilities in rural areas are poor. Primary education offers biblical and Islamic
	studies, English, mathematics, science, and an ethnic language. Secondary education
	lasts 6 years – schools are privately or state funded. Tuition at elite private high

FGM/C – early marriages	FGM/C was legally banned in 2015 at federal level - not in all states, and is hardly
	enforced. Of the women age 15-49, 19.5 % have undergone FGM/C, highest prevalence in South East and South West. 16 No uniform min. legal age of marriage.
	43% of girls in Nigeria are married before their 18th birthday and 16% are married
	before the age of 15. In North West and North East, 68% resp. 57% of women aged
	20-49 were married before 18th. 17 Women's situation generally is marginalized. 18
Situation of LGBTI	The Dec. 2013 federal Same-Sex Marriage (Prohibition) Act criminalises consensual
Situation of Eddin	same-sex sexual activity nationwide with 14 yrs prison, forbids supporting or
	promoting LGBTI rights and organizations (10 yrs prison). In the 12 states with sharia,
	adults convicted of engaging in same-sex sexual conduct may be subject to flogging or
